We currently have \$194,742.25 in Current Assets accounts. We have \$21,900.94 in Liabilities. This gives us a total Equity of \$172,841.31.

For March we have had an operating Loss of (-\$3,323.06).

I am still Working on amending the current budget to reflect spending in the remainder of the year and have started on setting up the budget process for the coming financial year. This should be completed by 15<sup>th</sup> June 2021.

A total check on all Croquet SA assets is almost finished and will be brought to charge on the books as at 1st July 2021.

## Risk Management
